

Here is the new scale of points for all C.A. R. awards except Publicity/Press Books and Yearbooks:

**Presentation 5 pts.** - neat, concise, includes all required information on the C.A.R. Awards Application Form (3 sheets allowed) or the Book of Evidence, if required.

**Achievement 65 pts.** - scope of project; need and fulfillment; benefit; accomplishment; comprehensiveness of work; activities to attain goals; evaluation of goals reached; educational; prior planning; very brief history, if continuing project; financial report; other.

**Participation 15 pts.** - size of club; involvement of members, community, government agencies, professionals, youth, residents in facilities, others. Not all of these have to be involved.

**Record or Documentation 15 pts.** - supporting data (as applicable)-- clear, well-labeled and neatly attached before & after photographs( if applicable), landscape plan (does not have to be professionally drawn), financial report, letters of appreciation, community awards, newspaper/magazine articles (if possible), radio or TV script (if possible), etc. Photocopies are permitted.

# All to see, lest we forget, those who help to keep us free.

With the planting of 8,000 Dogwood trees in 1944 by the New Jersey Council of Garden Clubs, so began a living memorial to veterans of World War II. In 1945, the National Council of State Garden Clubs adopted the program and began a Blue Star Highway System that stretched across the continental United States, sea to shining sea, and to Alaska and Hawaii with large metal Blue Star Memorial Highway Markers placed at appropriate locations along the way. The Blue Star became an icon in World War II, seen on flags and banners in homes, churches and businesses honoring sons and daughters away at war. Appreciation for those who defend our country has continued to the present day with markers placed at veterans' facilities, national cemeteries, parks and civic and historic sites.

Where does the Central Atlantic Region stand along this "Trail of Blue Stars?"

In C.A.R. there are currently 203 markers in the seven states that make up the Region. They honor the men and women who had served, were serving or would serve in the armed services of the United States.

Delaware Federation of Garden Clubs has 4 with the fifth being at the Dover Air Force Base. Federated Garden Clubs of Maryland, Inc. has 27; National Capitol Area Garden Clubs, Inc. has 13 and The Garden Club of New Jersey, Inc. has 30 markers.

The Federated Garden Clubs of New York State, Inc. has 47 while the Garden Club of Ohio, Inc. has 27. Finally, the Garden Club Federation of Pennsylvania has placed 55 markers in their state.

What better way to honor our service men and women who are defending our country than to install a Blue Star Memorial Marker in your community. I am creating a trifold that will display the seven states in the Central Atlantic Region with blue stars in-

#### **SCHEDULES**

The Basis of a Successful Flower Show

Many of us were fortunate to see "THIS GLOROIUS EARTH", the WAFA Flower Show in Boston this past June. While not a NGC Standard Flower Show with horticulture and education divisions, the schedule for the show was of utmost importance. Participants from the 30 member countries chose from the 25 classes listed in the schedule. Young people, ages 6-17, from the member countries also participated. Each class had a title or theme to interpret, such as "Fire"; "Wind"; "Storm" or "Water". Although there was not a scale of points as we know it, interpretation was most important. A sketch of the props with dimensions was provided.

The International World Show Rules for both divisions were listed in the schedule. The schedule also provided a necessary floor plan for designers, judges and public to navigate the enormous venue of the Seaport Convention Center.

While NGC Standard Flower Show Schedules have more requirements, the WAFA Show Schedule was similar in that it was the "back bone" or basis of the extraordinary international show.

The National Garden Club educates its members and the public in flower design, horticulture and environmental conservation through its flower shows. **The schedule sets the direction and level of excellence for our shows.** Whether a Small Standard Flower Show, a Standard Flower Show or an Advanced Standard Flower Show, a well written schedule brings creativity, order and direction to those participating and to those viewing the show. Refer to Handbook for schedule writing requirements.

The schedule need not be "fancy" or expensive...a single page on 9x11 card stock, front and back, is sufficient to write a schedule for a Small Standard Show. The theme selected for the show should be

evident throughout the schedule, including Design, Horticulture and Special Exhibits Divisions. Spacing and a variety of fonts makes a schedule easy to read. The cover should show the date, time and place. Rules clearly stated, table of contents, numbered pages, committee lists, awards offered all contribute to a successful schedule. Avoid repeating class requirements and class rules...remembering that economy of space and simplicity are economical and appealing to the participant and the public. Keep it simple!

C.A.R. is pleased to offer monetary awards to the most outstanding Flower Show Schedules in our region. Please submit the schedules from the clubs in your state to receive the regional and national awards.

#### PLANTINGS FOR PUBLIC and SPECIAL PLACES

Plantings for Public and Special Places is a 2011-2013 President's Project. Representing three areas of interest— Gardens with Edibles, Container Gardens, Trees and Shrubs. These plantings can beautify, have environmental value or provide sustenance. Possibilities exist for every garden club, regardless of its size, resources and energy levels. Clubs, districts and regions will be awarded Certificates of Appreciation and Participation by the NGC President. Details regarding categories and monetary awards will be printed on the NGC website. To receive this recognition, participants are asked to submit an online form (available on the NGC website), along with a *before* and *after* digital photo. Updates and TIPS that will inform and stimulate your creative gardening minds will be posted on the NGC website, as well (www.gardenclub.org).

Garden clubs may submit online forms for any or all of the three (3) areas of interest. Submission deadlines are April 1, 2012, and April 1, 2013. Plantings for Public and Special Places aligns extremely well with other areas of interests of our garden club outreach: Blue Star Memorial Markers, Habitat for Humanity Gardens, Penny Pines, Plant It Pink, Sage and Roses and Arbor Day Ceremonies, to name a few. Imagine the possibilities! With NGC Chairmen Pat Rupiper (Gardens with Edibles), Susan Robinson (Container Gardens) and Lissa Williamson(Trees and Shrubs), we are off to a terrific start.

Let's first look at what can be included in the area for which I am responsible-

#### Gardens with Edibles

- 1. Have you heard about Truck Farming? This interesting concept has legs (wheels) that offer a mobile teaching tool, right on the spot! Supported by Slow Foods, Inc. and Kitchen Gardeners International, farmers across the country are planting old pickup trucks with vegetables and driving them around to urban areas. City-dwellers (especially youth) get to see how vegetables are grown and how wonderful fresh vegetables taste. Visit <a href="www.truck-farm.com">www.truck-farm.com</a> to read about a Truck Farming National Project. As they are a not-for-profit organization, drivable old trucks or other support are needed. For more information, contact Natalie Morris, Wicked Delicate Films, LLC, Brooklyn, NJ, 917-392-0842 or go online to <a href="www.wickedelicate.com">www.wickedelicate.com</a>, <a href="www.wickedelicate.com">www.thecitydark.com</a>.
- 2. Receive permission from the city government to plant annuals into local tree spaces then add some vegetables such as kale, swiss chard, cabbage, etc. Start in a small localized area to determine how much work to maintain.
- 3. Create a vegetable and flower mix in large planter boxes at public libraries (or other city buildings). Be ready to switch out lettuce, carrots, beets, etc as they mature.
- 4. Help erect raised beds at schools and libraries and work with the students to identify and taste what you have planted. Many times the National Honor Students (or other school groups) need to have service hours and they can help. Make these beds small enough to manage efficiently. Try planting and tasting with story hour kids and their parents.
- 5. City Park Departments might have an area for a display garden; your garden club could work with those employees to prep the bed. The club could plant and maintain or work with a service group to have volunteers harvest for the hungry they serve. It is a wonderful scout project.
- 6. Work with the Master Gardeners to create a planting area and educate students.
- 7. As a garden club ask the local farmer's market about a booth for a day. Bring a potted edible garden and educational materials for hand out. **Maybe you will get new members!**
- 8. Host a flower show in a public place and include a section on edibles-both harvested and potted plantings. Have contact information and culture information available for handout. Make it more than one day for the greatest exposure. Once again you may be rewarded with new members to your club.

Remember, as the garden grows, so does the gardener!

#### THE CLEAN WATER FEDERALISM ACT OF 2011

#### How I Got Involved!

Let me start by stating that I am not a political person, frankly because I don't have the mind for it. So, the first thing I did after reading the article about the Clean Water Act sent to me by Marion Hillard, Chairman Environmental Concerns/Legislation National Garden Clubs, Inc., was to start researching the whys and wherefores of it. You need to understand something before you react to it.

The online site for the Act gave details-- none of which I understood. My next search led me to simple terminology and explanations of the many acronyms that give pause to a layperson. Here are brief descriptions of what I learned.

(EPA) Environmental Protection Agency: An independent agency of the federal government, overseeing many other agencies. (OW) The Office of Water: Office protects and guards our drinking water, aquatic ecosystems and oceans, in that it is responsible for executing the Clean Water Act and Safe Drinking Water Act, among many other acts. The OW works with the ten EPA offices and other federal and local agencies.

(NPDES) Nation Pollutant Discharge Elimination System: A permit program regulating pollutant sources that discharge into the waters of the United States.

Bill H.R. 2018 (Clean Water Act) severely limits the EPA and OW from disapproving or negating state-made decisions regarding clean water laws.

<u>Areas of concern</u> are intermittent streams, playa lakes, prairie potholes, sloughs and wetlands. States such as West Virginia and Florida have mining and farming organizations supporting this bill.

Do your own research and see if you agree with me!


