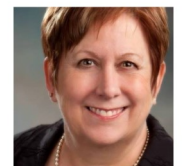

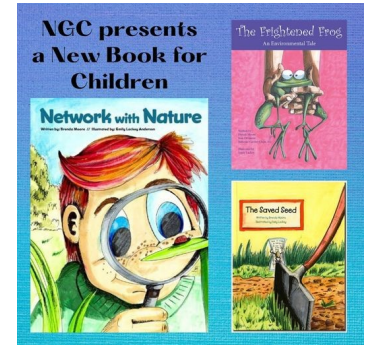

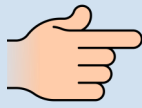

Elva's Protocol Pointers

- >The **Pledge** to the flag is said at the **BEGINNING** of the Opening Business Session **only**.
 - >The American flag is displayed to the **RIGHT** of the dais (and the Presiding Officer). It can be either on the same raised platform as the Officer or on the floor as the Assembly. The flag is seen on the left side of the seated Assembly facing the dais.
 - > **Introductions:** The Presiding Officer starts with those seated "to my **LEFT**" and moves to the Center podium; then turns and states: "to my **RIGHT**" and moves to the Center of the dais/head table ending with the Presiding Officer.
 - > Never state "I'd like to introduce the head table." **State** "I'd like to introduce those seated at the head table."
 - > **Order of rank:** Usually **ONE** distinguished guest is invited to attend a Convention but if you should choose to invite more than one: The Order of Introduction and seating would be Region Director, other NGC elected Officer, NGC President. If the other NGC Officer is appointed, the Officer is introduced first, then Region Director and last NGC President.

Patty's Parliamentary Procedure Helps Where Do We Begin?

Parliamentary procedure can be both simple and complex. There are many rules and procedures to learn, and it takes a great deal of time and commitment to learn them all.

Now, in the words of Julie Andrews, from *The Sound of Music*, "Let's start at the very beginning."

What is Parliamentary procedure? In a most basic explanation, it is a process to conduct meaningful and orderly business in any organization. It defines order and prevents chaos in meetings. It is only **one** of the sets of rules that govern an organization, and should be used only when the other rules, which take precedence over parliamentary rules, do not address or conflict with the higher-ranking rules. All the rules of an organization, in order of importance, are as follows:

- Federal and State laws governing corporations, tax-exempt organizations, public legislative bodies, etc.
- Articles of Incorporation – applicable to corporations
- Governing documents of parent organizations – applicable to chapters, affiliates, etc. of larger organizations
- Local Constitution and Bylaws which define the organization's basic structure and fundamental rules
- Standing Rules, or operating procedures, of the organization, working with all the above
- Parliamentary Rules of Order, or parliamentary authority, **which is superseded by any of the above rules on record for the organization.** Our ultimate reference for all things dealing with Parliamentary procedure is *Robert's Rules of Order, Newly Revised*, or *RONR*, as it is commonly referred. The Twelfth, and most recent edition, was published just a year ago, in September 2020. This book contains 633 pages of text, tables, and charts. The supplement to this new edition is *Robert's Rules of Order, Newly Revised, in Brief*. This supplement answers, in more understandable terms, some basics of *RONR*. However, it covers only the essentials, which is a good beginning for those just learning about Parliamentary procedure.
